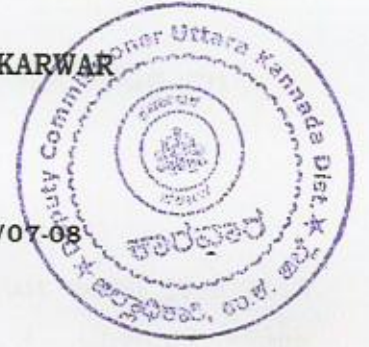

**Sub:** Appeal filed u/s 5(a) of Karnataka Scheduled Caste and Scheduled Tribes (PTCL) Act against the order of Assistant Commissioner, Sirsi dated: 28-05-2007 in file No. PTCL/Viva-4/06-07.

**Preamble:**

The Instant appeal was filed by Nagappa Ningappa Kotagunsi through Advocate Sri P. S.Bhat in the file No. RB/LND-II/PTCL/CR-5/07-08 u/s 5(a) of the Karnataka PTCL Act against the order of Assistant Commissioner, Sirsi No. PTCL/CR-7/06-07 dated 28-05-2007. After hearing the case Order was passed by this court on 19-9-2016. At the time of order typographical error was made while typing the name of appellant as Chennabasappa Ningappa Kotagunsi instead of Nagappa Ningappa Kotagunsi, and advocate name was typed N.S.Bhat instead of P.S.Bhat.
