Sub: Appeal filed u/s 56(1) of Karnataka Land Revenue Act-1964 against the Hissa Phodi in respect of Sy. No. 208A of Kasarkod Village in Honnavar Taluk.

Order:

The instant appeal has been filed by appellant Shri Parameshwar Pandurang Mesta, Taluk Honnavar against the Letter of Deputy Director of Land Records, Karwar in file no. ಕ್ರಸಂ/ತಾಂ(1)ಭೂಮಾ/223/16-17 dated: 20-01-2017 in respect of cancelation of KJP pertaining to Sy No. 208A of Kasarkod Village in Honnavar Taluk. Notices were issued to both parties but notices were not served to respondents and RPAD notices were return back reasoning of address not known. In spite of that many opportunities were given to appellant case was heard on 27-03-2017, 29-05-2017, 14-08-2017, 16-10-2017, and 20-11-2017. Appellant advocate was directed to take steps to reissue RPAD notice with proper address to respondents. But appellant advocate did not submit the proper address of respondents to the court. Hence, case is dismissed for non compliance and default.
