#### Conditions:

1. Successful bidders shall deposit 5% of the tender Amount within 20 days of issuing Letter of acceptance in form of BG /FDR.
2. The Deputy Commissioner has the right to accept / reject this tender.

3. Bidders who take over the program must complete within the stipulated time limit. Deferred progress will be penalized according to tender regulations.
4. Bidder quoted rate/ cost less than the estimated cost will be required to pay DD for the difference amount.
5. GST-returns and IT-returns for the year 2018-19 shall be attached with the tender.
6. The tenderer shall catch the stray dogs from the places suggested by employer, conduct ABC Programme as per standards specified by Animal welfare board of India and Prevention of Cruelty to Animals Act 1960 and feed and cater the stray dogs for 3 days after operation and rehabilitate them in the same place where they caught from.
7. The tenderer are encouraged to engage NGO's for ensuring the well being of stray dogs in the process
8. The welfare of the animal in the process is sole responsibility of the tenderer during operation and post operative period
9. In case of any causality during operation and post operative period tenderer is responsible .
10. The payment will be paid as per the jurisdiction of the Urban Local Body limit. The Project Director , District Urban Development Cell , U.K. is called the tender in the interest of the Urban Local Bodies. All payments and arrangements provide to the tenderer is the responsibilities of the ULBS.
11. The tenderer must inform the concerned Commissioners / Chief Officers of the Urban Local Body prior to the operation
12. The tenderer shall quote the rate inclusive of all applicable taxes such as GST etc..., The taxes will be deducted as per applicable laws while payment
